This case is recommended subject to following conditions :

1. The applicant will not start the college or give admission to the prospective students till a clear permission to that effect has been issued by DCI/GOI.
2. The applicant will follow all the directives issued by State Government from time to time.
3. Admission to all the sanctioned seats will be strictly in accordance with the procedure and the guidelines given by the Hon'ble Supreme Court/GOI/DCI/MCI from time to time.
4. Before starting the Dental College, the applicant will set-up hospital and other infrastructure as per the rules and regulations of DCI.
5. Fee structure will be in accordance with the decisions of the Fees Regulating Committee set up under orders of the Hon'ble Supreme Court, or as directed by GOI/GOR.
6. This Essentiality Certificate cum Feasibility and Desirability Certificate will be valid for two year from the date of issue.
7. It is further certified that in case the applicant fails to create infrastructure for the Dental College as per DCI Norms and fresh admissions are stopped by the DCI, the State Government shall take over the responsibility of the students already admitted in the college with the permission of the Central Government.


